- D. As clarification, the Cost Proposal is to **include** all applicable taxes, as stated in Part IV Evaluation Criteria, Section 2; and Part V, Section 2. Cost Proposal, Item C.
- E. Refer to 'BID FORM AND INSTRUCTIONS TO BIDDERS': Replace in its entirety with the attached revised Bid Form that states that the cost of the work is to **INCLUDE** applicable tax.

II. CLARIFICATIONS

The following responses are provided to written questions:

- A. Liquidated Damages will not be enforced on this project. However, as part of the evaluation criteria as outlined in the Request for Proposals, respondents must provide a proposed 'Construction Schedule'. This schedule will be part of the contract between the Owner and Contractor.
